The General Manager

Having regard to the Statute of the Sicilian Region;

Having regard to the D. P. Reg. no.704 of the 16.2.2018 with which, in execution of the resolution by regional Council n° 60, February 13, 2018, was provided for the assignment of General Manager of the regional Department of the Work of the regional Family, Social Policies and Work of the Miss Francesca Garoffolo;

Having regard of the regional law of 15 may 2000 no.10 and s.m.i.;

Having regard of the regional law of 21 April 2016 no.7 “the Discipline of the training contents for the exercise of the activities of commercial diving art. 4 establishing at the Regional Department of Work, Employment, orientation, services and training activities to the Repertoire of electronic communication for the exercise of the activities of commercial diving, trained people in the context of the activities referred to in art. 3 of the same regional law 7/2016;

CONSIDERED that with the Presidential Decree of 7 December 2018 no. 31 in the art. 2 are stated the rules for the Establishment of the Electronic Repertoire art. 4 of the regional law of 21 April 2016, no. 7 with the function of facilitating the meeting between demand and supply of labour, with reference to the professional activities related to the qualifications of the diving industry;

Having regard to the D. P. no. 31 of December 7, 2018, to art.4) requires that the registration of the Repertoire is on the individual instance of the individual concerned, addressed to the competent Office referred to in art.2, paragraph 2 of the regulation mentioned above.

Considering that the cited art. 4, paragraphs 2, 4 and 5, requires that the model application, the mode and content of the same, as well as the mode of payment and related amounts, will be prepared and approved by decree of the General Director, in order to proceed with the registration in the electronic Repertoire;

Considering that the D. D. 236/2019 of the Department of Economics – Department of Budget and Treasury – General Accounting of the Region – the Accountant General has established the chapter at entry 7691 chapter 15, book 3-in-chief of the Regional Department for Family, Social Policies and Labour - Rights of the issuing of the card in registered form provided for entry to the electronic repertoire operators of the diving industry – L. A. 7/2016 art 4. c. 6;

CONSIDERED that with the Presidential Decree of 7 December 2018 no. 31 in the art. 2 c. 2 it is established that executive measures will also provide for the allocation of any material resources necessary for the activation of the repertoire, including the release of the relevant card;

Considering that the D. D. G. n.3325, 14 October 2019, with whom the General Manager of the regional Department of work, employment, orientation, services and training activities, in accordance with the art. 2 of D. P. no. 31, 7 December 2018, identify the Structure and dynamics that take place obligations relating to the management and implementation of the electronic Repertoire, locate the person responsible of the procedure of publication on the internet website of the Department, sets directions for the activation of the website dedicated to the implementation of the above-mentioned Repertoire, telematics, and identifies the Consignee of the Department for the requirements relating to the supply of the Cards, including the purchase of equipment that will allow the processing and activation, in accordance with the provisions of art. 8 of the cited D. P. no. 31, 7 December 2018;

Considering that the D. A. no. 2281 of the 28/4/2019 we proceeded to the updating of the Repertoire of the qualifications of the Sicilian Region through the insertion between the profiles of “the regulated Training” of the three figures referred to in regional law 21/4/2016 no. 7;

CONSIDERED that the OTS (Operatore Tecnico Subacqueo) refers to the basic qualification necessary for the access to the courses, which allows you to achieve the qualifications regulated by: 1) Inshore diver or “sommizzatore”; 2) Offshore air diver “Top up”; and 3) Offshore sat diver “altofondalista”.

Considering that applicants, in order to be able to access the profiles of the “regulated Training” of the three professional qualifications, in order to participate to the course, must necessarily prove to be in possession of a qualification of OTS (D. M. 13/01/1979, M. D. 31/03/1981 and D. M. 02/02/1982) with the certificate of reconnaissance, in the course of validity, attesting the enrolment in a register of divers in a local service, referred to in art. 3 of the ministerial Decree of 13 January 1979, i.e. to be in possession of international certification of medical examinations, attesting to the suitability of the psycho-physical activities of the scuba diving industry (IMCA D-20/01 of the 02/07/2001).

Considering that the D. D. G. n. 4207 of the 28/11/2019 needs to be reformulated in order to make more explicit the correlation between the qualification of the OTS, whose possession is a necessary condition for access to the training courses, and the training courses themselves, as provided by L. R. 7/2016, data: Inshore diver “sommizzatore”, Offshore air diver “Top up” and Offshore sat diver “altofondalista”;

CONSIDERED, therefore, of the duty to proceed to the cancellation of the D. D. G. n. 4207 of the 28/11/2019 and attachments of the same (guidelines and application model) and the revival of what is necessary with the present Decree, in compliance with and in implementation of L. R. 7/2016 and D. P. R. S. n. 31, 7 December 2018;

DECREES

Article 1

For the reasons in the introduction above, cancelled the D. D. G. n. 4207 of the 28/11/2019;

Article 2

Is approved the modification of the model of the application and its annexes to be entered in the electronic Repertoire, provided for by the regional law 07/2016 and D. P. no. 31/2018, as well as the content in the "Guidelines" that are an integral part of the present decree;

Article 3

The registration to the electronic Repertoire is on the individual instance of the individual concerned in accordance with the details and the contents indicated in the Guidelines and in the model of the question";

Article 4

At the end of the release of the card, the individual concerned shall pay the sum of € 50.00 in the chapter on the entrance of the Regional Department of Work, Employment, orientation, services and training activities, n. 7691, chapter 15, book 3 of the regional budget, for the registration to the Electronic Repertoire for the exercise of the activities of industrial diving code financial E. 3.01.02.01.999, highlighting the reason of the **payment "Chapter 7691, chapter 15, for the release CARD to the Sub, including the name of the applicant"** ;

Article 5

This Decree, with the Guidelines and the attached application form and related attachments which form an integral part, will be sent to the person responsible of the procedure of publication on the website of the Sicilian Region for the purposes of fulfilling the obligation of publication of the content, pursuant to art 68 of the L. r. August 12, 2014 no.21.
