## **Guidelines to the D. D. G. n. 4741 of 10.12.2019**

The registration to the electronic repertoire of the Sicilian region, referred to in art. 4 of regional law n. 7 of the April 21, 2016, solely for the purpose of facilitating the meeting between demand and supply in the labour market, of the persons trained in the scope of the activities referred to in art. 3 of the same law (L. R. n.7/2016).

In this context, the repertoire does not assume any particular value, authorizing or qualifying the exercise of art or profession, nor shall any preference with respect to subjects, but the formats in accordance with the applicable provisions of the law, which did not require any inscription in the electronic repertoire of the sicilian region.

The registration to the directory is allowed only for those who possess a title awarded according to level of qualification among the three levels specified in art. 2 of the L. A. 7/2016.

The issuer of the title-state institutions, or public vocational training centres accredited by the Region, takes sole and exclusive responsibility of, as in the title, or certificate, content, along with that declared by the applicant.

Enabled to issue securities eligible are exclusively state-owned institutions, or public vocational training centres accredited by the Region, pursuant to the regulations currently in force and subject to its supervision.

May also require the enrollment to the repertoire, trained people, who have a title as long as issued, always, from in-state institutions or public or accredited centres from other regions.

Can be taken into account, for the purposes of inclusion to the repertoire, also, the titles who are recognizable, according to the EC directive 2005/36, which conform to the audit policy and endorsement provided for by the rules, and always in compliance with the standards referred to in art. 3, paragraph 2, of the L. R: 7 Inshore diver”, “Offshore air diver” and “Offshore sat diver”./2016.

In the latter case, the title should always indicate under the exclusive responsibility of the issuer, the title itself is under the exclusive and related responsibility for the subject format, and the applicant for membership, the membership of the same, as received, to one of the three professional qualifications wanted by the law 7/2016. and , anyway, in compliance with the provisions set out in Q. A. no. 2281, 28 may 2019 to the Department of Education and vocational Training of the Sicilian Region, where it is provided for the update of the Repertoire of the qualifications of the Sicilian Region through the insertion between the profiles of “the regulated Training” of the three figures of the aforementioned regional law April 21, 2016 no. 7.

Therefore, in each case applicants for the insertion of the repertoire must possess and demonstrate a title, issued by the state institutions or public or accredited centres as noted above and relative to one of

the three professional categories, expressly mentioned in art. 2) of sicilian regional law 7/2016, and corresponding to the levels called “Inshore diver”, “Offshore air diver” and “Offshore sat diver”.

It is noted that the outcome of the investigation done by the Office of the Department of Labour, Employment, orientation, services and training activities, relatively to the regularity of the title and of the documents submitted by the applicant for registration in the Electronic Repertory – art. 5 of D. P. R. S. n.31 of December 7, 2018 – does not replace itself, no certification issued by the authorities or authorized schools in the ways desired by the law 7/2016 and subsequent laws and regulations, because it only take note of the declarations authenticated, be transmitted, under the exclusive responsibility of the registrant relative to the law allows proof of claim and the time the fund made and reported through the LOGBOOK of the individual, as indicated in annex 1 of the DPRS no. 31/2018.

Pursuant to articles 14 and 17 of the Statute and in accordance with the principles of the current european order, the Region regulates the content and the learning pathways for the exercise of the activities of commercial diver, and subsequent entry to the electronic Repertoire is permitted to all those who have achieved a suitable title, within the meaning of directive 2005/36/EC of the european Parliament and of the Council of 7 September 2005, in order to facilitate the marketability in the labour market of the securities of training achieved and their recognition in the international office according to the level of qualification, accompanied by the contact information; the release of the “Card” referred to in art. 8 of the D. P. R. S. n. 31 of December 7, 2018, has the only function of recognition of the writing person and not in lieu of the certificates of permission, therefore, no match can be made between the card and the certifications or approvals which result in the release itself.
